RESOLUTION GCUB 001-2021

The Board of the Brazilian Association of Directors of Higher Education Institutions for International Cooperation – GCUB, in the use of its powers and in accordance with its Statute, amended on October 30, 2020.

Considering the need to establish criteria for joining new Brazilian universities, federal institutes from Brazil, and international institutions,

Considering the changes made at the Extraordinary Assembly on October 30, 2020, which amended the GCUB Statute, allowing the association of federal institutes of Brazil,

Resolves,

Art. 1 - To compose the GCUB membership, the Rectors of the Brazilian candidate universities must demonstrate that the institution fulfills the following membership criteria:

- I- Be regularly registered as a University or Federal Institute in the competent body of institutional accreditation.
- II- Demonstrate the character of an entity under public law (federal, state or municipal) or private law, but as a non-profit (community).
- III- Offer undergraduate courses in two or more major areas of the knowledge.
- IV- Offer at least a Doctorate and a Master's Degree, in different areas of knowledge, accredited by CAPES, and have active research groups, accredited by CNPq.
- V- Present consistent and sustained scientific, technological, artistic and cultural production, evaluated according to the standards of national funding agencies.
- VI- Demonstrate that internationalization is part of the institution's policy.
- VII- Justify the interest in joining the Association and declare willingness to pursue the purposes dictated by its Statute, rules and regulations in force.

Sole Paragraph - The simple fulfillment of the criteria defined above does not imply automatic acceptance of the affiliation proposal.

Art. 2 - Affiliation proposals must be addressed to the GCUB Board of Directors, duly documented and accompanied by a letter requesting membership, signed by the Rector of the institution or his legal representative.

- § 1 The proposal must be sent only in digital format, to the electronic address indicated by GCUB.
- § 2 If necessary, the GCUB Board will request additional documents.

Art. 3 - For the admission of International Associates, candidacies from Rectors whose institutions meet the following requirements will be considered:

- I- Be regularly registered in the country of origin in a competent body of institutional accreditation, such as Higher Education or Research Institutions, Associations or University Networks, Associations or University Networks, Councils of Rectors or equivalent and Cultural Centers, and meet the following criteria:
- II- In the case of Higher Education Institutions:
- a) Offer undergraduate courses in two or more major areas of the knowledge.
- b) Offer at least a doctorate and a master's degree, in different areas of knowledge, and have active research groups.
- c) Present consistent and sustained scientific, technological, artistic and cultural production, evaluated according to the standards of national funding agencies.
- d) Demonstrate that internationalization is part of the institution's policy.
- e) Justify the interest in joining the Association and declare willingness to pursue the purposes dictated by its Statute, rules and regulations in force.
- III- In the case of Research Institutions, Associations or University Networks, Associations or University Networks, Councils of Rectors or equivalent and Cultural Centers:
- a) Demonstrate that internationalization is part of the institution's policy.
- b) Justify the interest in joining the Association and declare willingness to pursue the purposes dictated by its Statute, rules and regulations in force.

§ 1° - The simple fulfillment of the criteria defined above does not imply automatic acceptance of the affiliation proposal.

§ 2° - The rights and duties of international Associates are described in Art. 9 and Art 10, of the GCUB Statute, respectively.

Art. 4 - Affiliation proposals must be addressed to the GCUB Board of Directors, duly documented and accompanied by a letter of request for membership, signed by the top director of the institution or his legal representative.

§ 1 - Proposals can be sent in one of the following languages: Portuguese, English, Spanish or French.

§ 2 - The proposal must be sent only in digital format, to the electronic address indicated by GCUB.

§ 3 - If necessary, the GCUB Board will request additional documents.

Art. 5 - The affiliation proposals approved by the Board of Directors will be communicated to the following General or Extraordinary Assembly of the Association, as provided for in Article 7 of the Association Statute.

Art. 6 - This resolution takes effect upon approval.

Art. 7 – Revokes the Resolution 001/2017.

Art. 8 – Revokes the Resolution 001/2020.
